WHAT: Richmond City Council will hold a special meeting to consider [ORD. 2020-231](#), to create a new reservation of fund balance called the 2020 Unfunded Other Post-Employment Benefits Liability Reserve, intended to be categorized as an assigned fund balance and used to fund the trust created by Ord. 2018-196, § 1, adopted Jul. 23, 2018, to provide other post-employment benefits to individuals who have terminated their service to the City and to the beneficiaries of such individuals; and [RES. 2020-R059](#), to make assignments of the calculated general fund surplus for Fiscal Year 2019-2020.
