### **CALL TO ORDER**

The meeting of the Richmond Electoral Board was called to order with Chairman James Nachman presiding. In attendance was Joyce Smith, Vice-Chair; C. Starlet Stevens, Secretary; Keith Balmer, Director and Caitlin Shelton, Executive Asst. to Director Balmer.

### **PUBLIC COMMENT PERIOD FOR ITEMS ON THE AGENDA**


**ADJOURNMENT**

There being no other business, Chairman Nachman adjourned the meeting.




