

Accelerate the equitable transition to healthy, resilient, climate neutral buildings and energy sources

Objectives

- Achieve climate neutrality and increase resilience in government buildings, infrastructure, operations, and energy supply.
- 2. Maximize energy performance and resilience in all existing buildings.
- Ensure all residents have equitable access to affordable and resilient clean energy.
- 4. Achieve climate-neutrality and maximize resilience in all new buildings.

Environment

- 3. Reduce risks and impacts to the community and natural environment from extreme precipitation and flooding.

Transportation & Mobility

Accelerate the transition for all to clean and equitable mobility systems

Objectives

- 1. Achieve climate neutrality in municipal fleet operations and increase resilience and stewardship of transportation infrastructure.
- 2. Create vibrant neighborhoods where all residents can easily ride transit, walk, or bike to meet daily needs.
- 3. Transition the community rapidly and equitably to clean-fuel vehicles and transit.

Waste Reduction & Recovery

Fostering sustainable methods of waste reduction - wasting less, reusing more

Objectives

Objectives vs. Strategies

Government Accountability Objective

Ensure that those who are most affected by local climate impacts are centered in processes for developing, implementing, and evaluating solutions

Add benchmarks/measura ble objectives to hold government accountable to (could have public scorecards that assess progress)

Will it be necessary to explain to some communities why they might be deprioritized vis a vis those currently underprivileged?'

The objective does not address how the government will be held accountable. It centers how they will value what neighborhoods/communi ties have to say which is good but still does not place accountability on

Buckets/topics for strategies:

- Develop infographics that show disparities between parts of RVA narrowing over the next 30 years [I'm thinking of the red/blue/green climate equity index maps]. This means budgeting for the data behind the vulnerability indices to be collected on a regular schedule over the next 30 years to be able to share the story of progress and success of the overall RVAgreen 2050 initiative. Determine a reasonable frequency for data collection [ie 5 yrs]
- Add deadlines into the strategies. like a process of how things will unfold
- Perhaps having a if-then scenario i.e. if the gov't does not uphold their end of the bargain then...
- Where does gentrification and urban green belong?
- Govt. providing updates to neighbors.
- Scorecards, for diversity of engagement and involvement in processes (work with community members to determine what we are being evaluated on)
