# Community Consultation #3 Report July 15, 2020





Community Consultation #3 was the third round of public engagement focused on obtaining community input on the draft *Richmond 300: A Guide for Growth* Master Plan document, which was released on June 1, 2020. This engagement effort was led by the Dept. of Planning and Development Review (PDR) and focused on engaging the community at virtual summits and virtual civic association and stakeholder meetings. In March 2020 the U.S. shut down to prevent the spread of the COVID-19 virus therefore PDR switched from hosting in-person meetings to virtual formats. Community Consultation #1 was held in September and October 2018 and Community Consultation #2 was held September through November 2019 and the Reports for each are available at <u>www.richmond300.com/consult</u>. # I. Promotion

Community Consultation #3 meetings were promoted in various methods:

- **Mayoral Announcement:** Mayor Levar M. Stoney was scheduled to host a Draft Plan Release Event which was cancelled due to COVID-19. The Mayor did attend and presented at City Planning Commission on June 1, 2020 to promote the release of draft *Richmond 300: A Guide for Growth* Master Plan document.
- Richmond 300 Email Notices: The *Richmond 300* email list has over 3,914 subscribers (an increase of over 400 since November 2019) as of July 13, 2020. From March 27 to July 10, the *Richmond 300* Team sent twelve (12) emails with an average open rate of 28.8% to the *Richmond 300* email list. 2,814 individuals opened at least one of the twelve emails.
- **Public Meeting Hearings:** The Richmond 300 team announced the Community Consultation #3 meetings and online content at several public hearings:

- Social Media: *Richmond 300* has a robust social media presence through <u>Instagram</u> and <u>Facebook</u>. The *Richmond 300* summits and online content were promoted on both platforms through Facebook events and Instagram posts as well as the *Richmond 300* <u>website</u>.
- **Engagement Team:** The Richmond 300 Engagement Team invited individuals throughout Richmond to virtual meetings by sending personalized emails, making phone calls, and forwarding communications from the Richmond 300 Team.

## III. Virtual Meetings

#### Leader Conversations:

After Community Consultation #2, the Richmond 300 Engagement Team Members met with PDR staff to discuss how to best proceed with their work of engaging with individuals who typically do not participate in planning processes as a part of Community Consultation #3. The Engagement Team recommended the focus be on reaching leaders of under-represented groups prior to the draft Plan release to educate the leaders on the forthcoming content and discuss how to use the plan once it is adopted, so that they can share information with their constituencies. The Engagement Team in coordination with the PDR staff planned four inperson Leader Dinners with community leaders to occur in March 2020. The Engagement Team played a major role in inviting individuals to attend and managing logistics for the dinners.

Due to the pandemic, the decision was made to cancel all in-person meetings prior to the first scheduled Leader Dinner. In mid-April, PDR staff met with the Engagement Team to discuss

how to move forward, and the Engagement Team stated that they felt the Leader Dinners could proceed successfully as virtual Leader Conversations.

The Engagement Team and PDR hosted six (6) virtual conversations focusing on different parts of the city or sections of Plan. The Engagement Team suggested the meetings be held at during work hours on weekdays. PDR added the 6<sup>th</sup> meeting as members of the Richmond 300 Advisory Council expressed concerns regarding not having an evening meeting option. In addition to the Engagement Teams' work to invite individuals to these Conversations, notice of these meetings was provided through the Richmond 300 email list. Prior to the meetings, attendees were asked to fill out a survey to share in what part of the city they lived and worked and which parts of the master plan they would be interested in discussing. Though each conversation was customized to the interests of the individuals in attendance, the format of the meetings were the same:

- 0:00-0:05 Participants arrive, read intro content on the screen (names and short bios of the people speaking/monitoring the meeting)
  0:05-0:10 Richmond 300 Engagement Team Member provides an introduction on the purpose of Richmond 300
  0:10-0:25 Mr. Mark Olinger, the Director of PDR, reviews the plan for CC#3, Richmond 300 Vision, Maps, and 6 Big Moves
- 0:25-0:35 Q&A from attendees
- 0:35-0:45 Ms. Maritza Pechin, Richmond Project Manager, reviews the nodes the attendees live/work near and a Goal based on the attendees interests
- 0:45-0:55 Q&A from attendees
- 0:55-1:00 Ms. Pechin provides a brief review of the next steps

#### Leader Conversation Focus, Date, Time, and Attendance

#### Virtual Summits

PDR hosted eleven (11) virtual summits which presented the Richmond 300 content by topic or Priority Growth Node location. The Summits were first scheduled to begin on June 2, 2020, but PDR staff delayed the meetings by one week due to the unrest in the city and the nation in early June. All Summits were scheduled for 6:00 PM on weeknights. The Summits were promoted via email blasts, Instagram posts, and Facebook events, and listed on the Richmond 300 website. Attendees were asked to register in advance to receive a link to the meeting. Additionally, the meeting link was published on the Richmond 300 website on the day of the Summit. After each Summit, the recording of the Summit and the Summit presentation were available on the Richmond 300 website for review and download. As of July 15, 2020, the Summit recordings were viewed 360 times and downloaded for 643 times.

Though the content at each summit varied, the format of the meetings were the same:

  - Reviews opportunities for comment in the meeting today
  - Master Plan purpose
  - Engagement to-date
  - Structure of the plan
- 0:10-0:25 Mr. Mark Olinger, the Director of PDR, reviews the plan for CC#3, Richmond 300 Vision, Maps, and 6 Big Moves

0:25-0:35 Q&A on first half

0:35-0:50 Ms. Pechin, members of the Richmond 300 Advisory Council, and/or other City staff with expertise in the Summit topic review of the goals and strategies for that topic area or the vision and primary next steps for that Node

0:50-0:58 Q&A on second half

0:58-1:00 Final instructions on how to provide feedback

# IV. Online Engagement

The online engagement offered individuals the opportunity to review the draft content on their own time and included two components outlined below.

#### Draft Richmond 300: A Guide for Growth Interactive Document

The Draft *Richmond 300: A Guide for Growth* document was available for download at the Richmond 300 website and on an online platform, Konveio, which allowed for direct comment onto an interactive PDF. In addition to individuals being able to comment on the PDF, they could see and comment on the comments of others. See appendix for an excel sheet of with the 779 comments that were on the document.

#### Draft Future Land Use Map

Richmonders were able to download and review the Draft Future Land Use Map and write comments directly on interactive a Draft Future Land Use Map and a Future Connections Map. PDR staff received 50 comments on the maps.

## V. Engagement Profile

As detailed above, PDR engaged approximately **1,202 individuals** during Community Consultation #2 via in-person and virtual meetings and collected received **829 comments on the draft plan and maps**.

Limited demographic information was obtained during Community Consultation #2. Participants were asked to complete a poll at the beginning of each virtual summit. The poll results did not reflect the demographics of the participants as many did not complete the survey and individuals who attended multiple meetings may have completed the poll multiple times. Additionally, demographic questions were not asked of individuals providing their comments using the interactive document and map.

# VI. Comments Collected

During Community Consultation #3, PDR collected comments from Richmonders via many methods.

- 779 comments on the draft document entered in the interactive PDF. See appendix for text of the comments.
- **70 letters and emails** were submitted by individuals, civic associations, and special interest groups. See the appendix for the letters and emails received.
- 50 map comments were provided via the interactive online map. See appendix for text
  of the comments.
- **318 questions** were asked during 11 virtual summits.
- **360 views and 643 downloads** of the virtual summit recordings as of July 15, 2020
