A special call meeting of the Aging & Disabilities Advisory Board (ADAB) Governance Committee for the purpose of reviewing the City of Richmond ADAB Proposed By-Laws was called to order at 2:17 pm on Tuesday, August 9, 2022, with a welcome from Chairperson, Mark Bouziane.

Mr. Bouziane explained to the committee members how the review procedure would follow with each article and section being read aloud followed by questions and discussions with amendments as needed. Committee members will vote on changes to each section as they move through the document with a final vote of the document in its entirety after full draft had been reviewed. The final reviewed and amended document will then be presented to the full ADAB at the next special call meeting scheduled for 8/11/2022 at 12 noon to be held at Huguenot Community Center, 7945 Forest Hill Ave; Bld.# 26, Richmond, VA 23225.

#### **ARTICLE I: ADVISORY BOARD NAME**

Article I: Advisory Board Name was read aloud by M.Bouziane; J.Clay asked question about why individuals with intellectual disabilities was not included; Y.Jones explained that the Office of Aging & Disability Services (OADS) does not provide community-oriented or consumer based programs and services for this population; motion to accept as written by M.Bouziane; moved by J.Clay; 2<sup>nd</sup> by Y. Jones; all in favor; motion passed.

## **ARTICLE II: PURPOSE**

Article II: Purpose was read aloud by M. Bouziane. Recommended amendments to this article were 1) insert the word "adults" after older to read, "...information and recommendations to the City of Richmond on services for older adults"; (2) insert the words "strive to" after shall to read, "The Board shall strive to improve...".

There was a question for clarification of item #5 on the Board's role and the intent. After discussion it was determined that the intent of item #5 was that the Board will provide support to the OADS in the program and service design, development and oversight that is put in place by the staff and the OADS staff and can seek out the expertise of the ADAB members as needed.
