**Instructions to voters**

**To vote for a candidate**, use a black pen to fill in the oval next to the name, like this:



**To write in** a person who is not already on the ballot, fill in the oval and write the name of the person on the line.



**To vote on a question**, fill in the oval next to Yes or No.

**If you want to change a vote** or if you have made a mistake, ask an election worker for another ballot. If you make marks on the ballot besides filling in the oval, your votes may not be counted.

**Instrucciones para votantes**

**Para votar por un candidato**, use un bolígrafo negro para rellenar el óvalo al lado del nombre.



**Para votar** por un candidato que no está en la tarjeta, rellene el óvalo al lado de la línea "Nominación directa" y escriba el nombre de esa persona en la línea.



**Para votar sobre una pregunta**, rellene el óvalo junto al "Sí" o al "No".

**Si desea cambiar una de sus selecciones** o ha cometido un error, pídale otra tarjeta de votación a un funcionario electoral. Si hace marcas en la boleta además de llenar el óvalo, es posible que sus votos no cuenten.
