


Sanitary Sewer Replacement Work – 2100 Barton Ave. and North Ave. Alley

Project Information

The City of Richmond Department of Public Utilities (DPU) is replacing deteriorated sewer mains which are at risk of imminent failure and reinstating associated sewer service laterals in the alley along the 2100 block of Barton Avenue and North Avenue. Work also includes gas relocation which is currently ongoing as well as above ground water bypass operations. The total scope of work will require shutdown of the alley between E. Roberts Street and E. Battery Street. To prevent damage to existing utilities such as gas and water, utility surveys will take place prior to the start of work which will require access to residential properties. The project will commence March 2024 with an anticipated completion date of November 2024, barring any weather delays or unforeseen circumstances. The worksite is bounded to the north by E. Battery Street, to the south by E. Roberts Street, to the east by Barton Avenue, and to the west by North Avenue.



Maintenance of Traffic

A Maintenance of Traffic (MOT) plan has been developed by the Contractor performing the work and approved by DPW. The alley will be closed at all times, and the closure will remain in place 24/7 until the completion of the work. Work hours are scheduled from 7:00 am to 6:00 pm daily, Monday through Friday. During the work, there will be large trucks and other construction equipment operating daily, which will result in an increased level of noise during working hours. Local residents that live within the work zone will be provided safe access to and from their homes through the work zone. *Please note that 7:00 am – 8:00 am will be dedicated to staging construction, so there will be minimal noise.*

Impacts to Utility Services & Trash Collection

Each resident will be notified a minimum of 48-hours prior to any work commencing on their respective sewer service lateral that is anticipated to impact their sewer service. Likewise, advance notice will be given for temporary disruption to water and gas. This notice will be provided via a "door hanger" style tag that will be hand-delivered to the specific impacted residents on an as-needed basis. In some instances, select trees will require removal as well which may also impact other utility providers such as Dominion Power. The contractor and/or utility provider will notify the resident when their power is anticipated to be disrupted. Disruption will be minimal, and advance notice will be given.

Since this project impacts the alley that many residents utilize to access the rear of their homes as well as trash collection services, the City of Richmond DPU and Department of Public Works (DPW) have been planning and working together to deliver a successful project while ensuring minimal disruption to local residents.

Sewer Replacement FAQs

What is the purpose of the project?

To replace multiple sections of sanitary sewer that are at risk of imminent failure. Most sewers were installed in the early 1900's and have deteriorated to the point that they have begun to leak, have failed (collapsed), or are at risk of failure. Multiple in-place repairs have been attempted in recent years but have proven unsuccessful. It has been determined that the entire sewer needs to be replaced and relocated to address chronic issues associated with these sewers.

How will this project affect my sewer service, and how will I be notified?

Our goal is to minimize the impact on residents to the greatest extent possible. As the project continues, the contractor will notify residents via door hanger notices prior to work starting on your sewer service. There may be times when you are asked to limit or reduce the amount of water you discharge to the sewer. A separate door hanger or verbal notification from the contractor will advise you when your sewer service is going to be affected.

Will I be able to access the garage or driveway behind my house?

Rear residential access will only be permitted if the section of the alley is not closed at that time. Residents should not plan on being able to drive to the rear of their home while construction is ongoing.

How will traffic be affected?

The Maintenance of Traffic Plan will be implemented in phases as detailed on the prior pages. Front resident access to properties adjacent to the worksite will be maintained, but through traffic in the alley will not be allowed. Road closures will be posted on the Department of Public Utilities street closing Twitter feed (@DPUStreetNews). Every effort will be made to allow access to residences when it's feasible and safe.

How will parking be impacted?

Please observe and follow directions of "Closed Lanes" and "No Parking" signs around the work zone areas. Parking will be limited for the safety of citizens as well as construction personnel. Any areas of No Parking will be posted as far in advance as possible, but at least 48-hours in advance of the work being performed.

How will I enter my property if my residence is located within the immediate work zone or the larger traffic detour?

Residents, guests, contractors and delivery trucks will have 24/7 access to the front of the properties. If you reside in a neighborhood where direct access is blocked due to road closures, please follow all traffic signage to access your property. Front access to private properties will be maintained; however, during gas service connection, immediate front residential access may be limited for a brief period.

How can I coordinate deliveries and access to my property if I am out of town?

If you live within the work zone, send an email to <u>James.Kvaternik@RVA.gov</u> with your name, address, phone number and expected delivery times and the contractor will coordinate access upon arrival to the work zone. If your address is not within the immediate work zone, deliveries will not be impacted by this project.

How will trash collection be impacted?

Trash collection times will not be impacted by this work; however, residents who live within the immediate work zone based on the respective phase will need to take their trash to the nearest road or at the start of the alley closure, whichever is closest to the resident. If the resident if physically unable to move the trash bins to the pick-up location, send an email to <u>James.Kvaternik@RVA.gov</u> with your name, address, and phone number so trash collection and recycling can be coordinated.

Will law enforcement be present in the work zone during construction? No.

Will traffic be redirected through adjacent residential streets?

No. "No Thru Traffic" signs will be posted at the entrance to the alleyway at E. Battery Street and E. Roberts Street.
