
## Forest Hill Avenue Sewer Upgrades - History

#### Summer 2021

- Sewer at 6935 Forest Hill Ave collapsed.
- Emergency replacement of one line section completed that summer.

#### • Spring - Fall 2024

- Two sewers collapsed in front of 6815 Forest Hill Ave on consecutive days.
- All sewers in FHA from Windsorview to Powhite Pkwy rehabilitated.
- Sewer on south side of FHA replaced from Joe Brooks to Hathaway.




# Forest Hill Avenue Emergency Sewer Replacement – Strategy

#### Phased Approach


- The City investigated sewer mains from Chippenham Pkwy to Powhite Pkwy.
  And identified deteriorated sewers that can be rehabilitated as well as sewers
  that are blocked, collapsed, or deteriorated to the point that replacement is
  necessary.
- Ph 1 Sewer Rehab Work along Forest Hill Ave (FHA) from Melbourne Dr. to the Powhite Parkway – Completed in 2024
- Ph 2 Replacement of approximately 1,200 LF of sewer along FHA from Cherokee Rd to Hathaway Rd. – Completed in 2024
- Ph 3 Sewer Lateral Installations extended from turn lane to properties along the north side of FHA between Joe Brooks and Hathway. – September 2025
- Ph 4 Replacement of the remaining sewer along 6700 & 6800 blocks of Forest Hill Ave. (between Phases 1 & 2 above), the 2900 block of Hathaway Rd., and the 6900 block of Old Westham Rd. – Spring 2026




#### Phase 3 Project Scope






#### Phase 3 Project Traffic Impacts





#### Phase 3 Project Traffic Impacts – cont'd


- Lessons Learned & Implemented in this MOT Plan
  - Install & relocate Maintenance Of Traffic at night to minimize confusion for travelling public.
  - Do not impact Hathaway and Cherokee intersections concurrently if avoidable.
  - Tighter spacing of traffic control devices.
  - Minimize phasing/transitions.





### Schedule for Remaining Sewer Replacement along FHA Corridor

- Northern Lateral Extensions (Phase 3)
  - o 9/2/2025: MOT installed at night
  - 9/8/2025: Sewer replacement work starts
  - o 10/17/2025: Sewer Replacement work completed
  - o 10/20/2025: Restoration and MOT demobilization starts
  - 10/31/2025: Projected Final Completion
- Future Sewer Work Along FHA (Phase 4)
  - o Spring 2026 Construction Notice To Proceed
  - Spring 2027 Final Completion





#### **Overall Sewer Infrastructure**

- The City's priority has been proactively protecting the traveling public and maintaining sewer and water service to all City residents once the initial failures occurred and the broader issue was identified.
- It was concluded that approximately 7,000 LF of sewer rehabilation and replacement is necessary along this corridor to accomplish this
- Approximately 5,500 LF completed in this corridor between Chippenham and Powhite since 2021)
  - 3,695 LF of sewer was proactively rehabilitated avoiding an estimated additional 2-yr of open cut construction work in the public ROW along this corridor.
  - For context, over the lifetime of the sewer rehab program (since FY 2009) 410,262 LF of sewer has been rehabilitated and 40,902 LF of sewer has been repaired or replaced.

Impacts: 9 am – 4 pm closure; Monday – Friday
