Meeting Minutes September 17th, 2025

CALL TO ORDER

Chair C. Starlet Stevens called the meeting to order at 11:00 AM with Vice Chair Kate Maxwell and Secretary Joyce K. Smith present.

PUBLIC COMMENT PERIOD FOR ITEMS ON THE AGENDA

There were no public comments regarding items on the agenda.

APPROVAL OF THE MINUTES

Caitlin Shelton, Executive Assistant to the Board, presented meeting minutes from August 21st and August 27th, 2025. Vice Chair Maxwell moved to approve all minutes, and the motion passed unanimously.

PUBLIC COMMENT PERIOD FOR ITEMS NOT ON THE AGENDA

CLOSED SESSION

PUBLIC SESSION

Christian Javins, Election Services Manager, and Seth Hamalainen, Warehouse Technician, provided an update on ADA compliance. They reported that compliance was completed for all precincts, with one problematic precinct identified along with a proposed resolution. Vice Chair Maxwell moved to approve the ADA compliance and sign-off, which passed unanimously.

Chair Stevens expressed gratitude to Director of Public Works Bobby Vincent and Chief of Construction & Inspections Joseph Davenport for their assistance in completing ADA compliance for all 72 City of Richmond precincts.

Vanessa Floyd, Election Officer Manager, presented a list of 11 new election officers from both parties. Chair Stevens moved to approve all officers, and the motion passed unanimously.

Following the closed session, General Registrar David Levine addressed Executive Order 53 regarding enhanced election security. He noted that no guidance has yet been received from the State Department of Elections on local impacts but recommended vigilance in monitoring updates. Vice Chair Maxwell suggested scheduling a future meeting to discuss this matter further.

MEETING ADJOURNMENT

Vice Chair Maxwell moved to adjourn the meeting at 12:40 PM. The motion was unanimously approved.
